3 GENERAL ASSEMBLY

→ 3.1 SUMMARY OF CONCLUSIONS OF THE GENERAL MEETING OF 04 JUNE 2024



Closing of the 2023 financial year

The auditors audited the accounts and gave favourable opinions. The Chairman asked whether the members present at the General Meeting considered the financial year correct and, if so, whether they could grant the Quitus. There being no questions from the floor, the Chairman concluded that, by our Articles of Association, the Board of Directors responsible for our Association's sound financial and administrative management in 2023 was discharged by the General Meeting and granted a **formal** discharge.

Statutory matters

The electoral regulations for the Board of Directors have been adopted and are in line with Belgian ASBL regulations. They will be sent to the legal authorities in Belgium. The Chairman thanked his colleagues, particularly Mr Hendrik SMETS, for the quality of this work.

The amendments to the current Statutes were neither numerous nor essential. It was noted that Article 23 requires that "each change of Board of Directors requires an amendment to the Articles of Association." All that needs to be done is to state in the Articles of Association that "every three years there is a change of Board of Directors following elections and that the regulations are deposited." Regarding the name of our Association and the establishment of intellectual property, the President specified that our name is **SFPE-SEPS**, and it will appear as such on all our documents.

Appointment of two new members to the Board of Directors

Following the co-option as members of the Board of Directors of Messrs **Gianfranco Selvagio** and **Jan-Willem Bronkhorst**, the General Meeting confirmed their inclusion, meaning our Board has been enlarged.

Legal assistance to members

Mr Carlos Mourato, our reference lawyer, ceased his activities as a lawyer on 1 March 2024, having taken a new career direction, and had to be replaced. Following the decision taken by the Board of Directors, we looked for and found two lawvers: Mr. Levi from Cabinet Lallemand-Legros (our reference law firm), who agreed to work with us, and Mr. Orlandi, who is willing to help us with an ad hoc basis. The General Meeting endorsed the proposal by the Board of Directors and approved the choice of these lawyers.

International recognition of ISIS

The General Meeting supports the approach adopted, which is that it is essential to work towards international recognition of JSIS, which will, in the future, be authorized to provide S1 forms. We are affiliated with a health insurance fund with no legal framework. Article 90§2, which we introduced on this subject, has gone unanswered by the authorities and is therefore considered to have been rejected. This is highly unsatisfactory. We need to keep a close eye on this issue shortly.

→ 3.2 FIRST GENERAL ASSEMBLY OF SEPS-ITALIA

n 26 September 2024, the SEPS-Italia branch has held its first General Assembly, which can be considered as the founding event towards an autonomous Association, which will soon be formally registered at the chamber of commerce in Varese.



Following to a convivial meal at the nice premises of the prestigious Golf Club dei Laghi in Travedona-Monate, the meeting took place in a hybrid format, to allow interested persons to remotely attending and order to join in on-line.

The Chairman of the founding committee of SEPS-Italia, Gianfranco Selvagio, opened the meeting with a presentation of the agenda. Then, he gave the floor to the Chairman of the SFPE-SEPS, Pieter Kerstens, who was present at the meeting in person.

Pieter Kerstens congratulated SEPS-Italia with the significative achievements implemented by SEPS-Italia since a few years already, which finally result in the establishing of an autonomous Association, to which he gives his fullest support. The creation of SEPS-Italia has,

nonetheless, substantive effects on the structure and functioning overall currently existing SFPE-SEPS.

Thus, it requires to proceed with the creation of an International Association (AISBL), which will ensure the future coordination between the autonomous sections as well as the contacts with the European Institutions and the Trade Unions. Certain components of the current SFPE-SEPS will remain centralized, like the Bulletin and the Website. It is foreseen to allocate an own monetary budget to the newly created SEPS-Italia.

These organisational changes will not impact on the main objectives of the whole SFPE-SEPS, which are upheld as such. Indeed, we are all fighting for the very same issues.

Gianfranco Selvagio took the floor, for the presentation of the draft Statutes of the new Association. The details have been retained in that document and will also be developed in the internal minutes of SEPS-Italia. Globally spoken, these Statutes correspond faithfully with those of the current SFPE-SEPS, with some adjustments at local level, required to comply with Italian law. It is the fruit of a preparative work of several months performed by a group of volunteers within the section, who have invested themselves to find the best possible approach.

During the meeting, several suggestions to the content are

brought up by the participants. Most of them are adopted and will be included in an enriched draft. Those aim to make the current version more exhaustive, and to foresee a separate election regulation.

Having completed the presentation of the new Statutes, Gianfranco Selvagio, goes into the other points mentioned on the agenda. He communicates, amongst others, the appointment of two new SEPS-Italia ambassadors with the JSIS Settlement Office in Ispra; the rotation of the telephonic duty services for the support to the members; the agreement by the Administration to include SEPS-Italia representatives in the COPAS; and the active involvement at several retirement preparation seminars in Ispra. which will shortly be offered in Italian language. Finally, there has been a discussion on the difficulties (or rather the lacking) of multilingualism at the unique phone extension of the PMO and on the obstacles to contact it. The late distribution of the comparative survey on the costs of living, performed by Eurostat, has been put into question. Pieter Kerstens confirms that he will address the concerned services on it, including a request to extend the deadline for responding.

At the end of the meeting, Gianfranco Selvagio thanks all the participants for the interest shown, Then, he closes formally the event, which will be soon followed by other gatherings.

4 INFORMATION MEETING

VISIT FROM THEN PMO REPRESENTATIVES

At our last Information Meeting, held on 04 June 2024, following the Statutory General Meeting, we were pleased to have members of the PMO's senior management as guests—and more specifically, **Mr. Christian Levasseur**, Director; **Ms Catherine Heldmaier-Régnier**, Head of the Pensions Unit and Deputy Director of the PMO; and **Mr. Roberto Rotter**, Head of the 'Relations with JSIS affiliates' sector.



In his speech, **Mr LEVASSEUR** thanked the PMO for inviting him to address the SFPE-SEPS Assembly for the first time, as he had only been with the PMO for six weeks. His two colleagues assisted him in answering particular questions.

INTERNATIONAL RECOGNITION OF JSIS

One critical issue for all our members is easy access to healthcare throughout the European Union. We must follow the logic of the European Union plan because members' needs are not identical in all Member States. We mustn't forget that the JSIS's vocation is to cover European healthcare since not all its customers are in Belgium.

Consideration is given to a legislative act that could establish recognition of the JSIS in all Member States by regulating the Parliament and the Council. It's complex because we have two legal frameworks: the Statute, which

cannot change, and the national healthcare systems. DG Employment ensures the coordination of healthcare systems between Member States, notably through Regulation (EC) 883-2004.

The *MyCareNet* project is almost ready in **Belgium**, but tests still need to be carried out. Before that happens, the final data protection issues must be clarified and resolved. The information received from doctors is medical and, therefore, sensitive because it is subject to medical confidentiality.

MyCareNet will eliminate the paper form in Belgium. The project will be rolled out in different phases: the first phase is for general practitioners and specialists, followed by dentists and, finally, other healthcare providers.

At a later stage, the system is also planned to be used to purchase medicines from pharmacies.

In **Italy**, the PMO and DG HR are discussing an agreement with the national authorities to open access to the Italian primary system. What remains to be resolved is the management of reimbursements, information, and financial flows between Italy and the JSIS.

Regarding **Luxembourg**, the PMO is aware that the amounts billed for care are too high compared with what it considers reasonable regarding classification and pricing details. Discussions with the Luxembourg authorities are underway to try to make progress on this issue.

Obtaining care without a "carte vitale" isn't easy in **France**. Things will be even more complicated in a few years because we'll be increasingly digital, and the PMO must ensure that it is appropriately integrated into the healthcare system. This is a work in progress.

There is already close collaboration with the national mutual CZ in **The Netherlands**.

WORKLOAD AT THE SICKNESS INSURANCE

There are currently 53,000 active members paid each month and 32,000 pensioners, bringing together 180,000 members of the Joint Sickness Insurance Scheme. At the PMO, 600 colleagues provide services to the staff of all the EU institutions and bodies. They are geographically spread over three separate sites.

Access to the PMO's services is via several different channels:

- Online: The PMO teams process tickets or requests submitted online using a new ticketing system.
- The single number +32 (0)2 2911111, installed in February 2024, with feedback of 2 types:
 - Opening hours. Some colleagues would like more extended opening hours. The problem is that the people who process tickets are the same people who answer the phone. A permanent stock of tickets (around 4,000) is still being processed, which is challenging to reduce.
 - The architecture of the telephone menus. The PMO doesn't have a better choice, and they are currently looking at the redirection figures, the figures for redirections in the menus, to try and restructure them more appropriately. The issue of multilingualism still needs to be improved.

In 2023, the JSIS processed more than 3 million claims with acceptable turnaround times. A good balance must be struck between the staff who welcome members and those who process the submitted claims. Unfortunately, the total number of human resources at the PMO is fixed and non-extendable. We, therefore, need to manage this shortage as effectively as possible.

KEEPING IT ON PAPER

The PMO must remain attentive to colleagues who cannot use MyPMO in challenging situations. That's why we're currently investigating a proxy mechanism that would be better supervised than the one already in place.

To the question from fellow pensioners about keeping paper applications, although it is annoying in management, the PMO will be obliged to continue managing paper applications.

Ms. HELDMAIER-REGNIER is the Head of the Pensions unit and, more generally, for everything related to post-activity. This includes unemployment benefits, survivor's pensions, and the transfer of pension rights. There are 32,000 pensioners, working people about to leave the institution, and the beneficiaries.

As with the RCAM, the Pensions department's problem is determining where the cursor should be placed, where intervention and more individualized support are needed, and how to use the resources available rationally.

THE PERIODIC DECLARATION OF LIFE

The PMO now operates a system that means that a declaration of life is no longer required systematically, having created a direct computer link with the activities in the JSIS reimbursement system. As a result, the date of the next deadline for submitting the declaration of life is automatically postponed by one or even two years, depending on the age of the person concerned and any entries made by that person in the JSIS. The PMO has closed a relatively large number of outstanding declarations of life.

Contingency of pension payments

Several pensioners asked what is planned to ensure continuity of payments in the event of war or electronic attacks by malicious elements. The answer is that this is part of the contingency plan drawn up by DG BUDG. The plan is for DG BUDG to pay and encode the previous month's pension by default, which will be adjusted subsequently. This gives us a reliable presumption of the amount paid in the

last month, and DG BUDG also has additional mechanisms for making manual payments.

Mr. ROTTER has joined Mr. Levasseur's management team as part of the drive to strengthen the Sickness Fund's central office and ensure its smooth operation. The PMO is facing several significant challenges.

Generalization of third-party payment

Over the next five to ten years, we will move towards generic coverage in all healthcare systems. Members, patients in general, and individuals will no longer receive bills or paper directly from the doctor, the pharmacy, the hospital, or the therapist, as is the case in national systems. All the documentation will be sent directly to the health insurance company, which, as is already the case in some countries, will periodically calculate and inform you that you have had such and such a service, or such and such a doctor, or such and such an operation, and, with the result, there will be a statement listing the amounts disbursed, those eligible for reimbursement, and the difference corresponding to your excess, which is 15%, or the applicable co-payment. So, this will significantly impact the kind of management we're moving towards, namely widespread third-party payment.

Coverage

It's important to remember that reimbursement is not an obligation now. It is a facility offered to members by the PMO. Certain hospitals may no longer be reimbursed because of past abuses.

Multilingualism

We are doing our best to respond to multilingualism in as many languages as possible. Given the limited resources, we can't demand a response in 24 languages.

However, when it comes to your documents, the PMO never asks the doctor to draw them up in another language. We say that if you want things to go faster, such as the processing of your prior authorization, and if you can provide us with a translation, this will speed up the processing of your file. But if you can't, the PMO will always find a way to obtain a document translation, which will be processed.

If the PMO cannot answer you by telephone, for example, in Czech, we will note your telephone extension (in English or French) and contact you again in your preferred language, your mother tongue.

However, the main problem is with the survivors' pensioners. Survivors' pensioners know nothing about the system, and often, what do we do? We make appointments with them by phone or in person when it's impossible to sort things out over the phone, and the person must travel. It must be said that we try to apply our rules very intelligently.

The Chairman thanked the PMO guests for taking the time to meet with us and answer our questions. We appreciate their availability.

5 DID YOU KNOW?



→ 5.1 TERMINATION OF ALLOWANCES – TERMINATION OF JSIS COVERAGE. EXTENSION OF THE JSIS COVERAGE

Allowances for dependent children are no longer paid out for a variety of reasons:

- If the child reaches 26 years of age, even if he/she has not finished his/her studies
- If the child ends his studies (BAC or end of secondary school education) even if he/ she has not reached 26 years of age

Automatically, on the same day, the child is no longer covered by JSIS (whether for primary or complementary cover).

An **extension** of JSIS cover can be granted, for **a duration of maximum 12 months**, when a beneficiary is no longer a dependent of a JSIS affiliate. Such extension is not automatic. The affiliate needs to make a specific request, justifying his/her request, for example in the following events:

- If the dependent child has terminated his/ her studies and after the school holidays, he/she will start further education; A request for extension is necessary in order to re-establish coverage so that he/ she can be covered during the holidays. The administrative services will study the request file and the payment of allowances and JSIS coverage will automatically be re-established after assumption of further studies.
- If the child begins a job where no social

security deductions are made: for example during a training course/internship (style "Blue Book", Erasmus) "paid" only by an allowance; and that he/she does not immediately begin a professional job

- If the child has a waiting period for the reimbursement of his/her medical expenses
- For the ex-spouse, if there is a waiting period before his/her health costs are reimbursed.

Registration for social security/proof that social security contributions are not being made during the training course/internship need to be documented. Indeed, some countries require a waiting period of up to 12 months from registration for social security before any reimbursement of medical expenses can be obtained.

The allowances will be re-established retroactively to cover the school holidays prior to inscription. Health insurance coverage will also be reinstated and the request for extension will be administratively speaking "annulled" since it will have become pointless. The affiliate will therefore not have exhausted this possibility. Later a new request could be introduced, if the circumstances remain similar (for example if the child, less than 26 years of age, begins a Masters or its equivalent

or if between the end of the Masters and the commencement of a training course/internship without social security contributions).

IMPORTANT:

At the end of the maximum twelve months extension of coverage, the beneficiary will no longer be covered by JSIS unless he/she still qualifies under the "beneficiary" preconditions, namely resumption of studies (thus reinstatement of the allowances) and still under the age of 26, or the recognition of the dependent child remaining dependent due to his/her disabilities and consequent inability to become autonomous and on the assumption this qualifies for the attribution of allowances.

At the termination of the primary JSIS coverage the affiliate needs to request an attestation of termination of coverage from the competent services in order to be directly covered by his/her new social security scheme without a preliminary waiting period.

2. General Implementation Provisions (GIP) concerning the health insurance cover of civil servants of the EC,

extract from the text of 2007, Chapter 2, point 7:

<u>Joint regulations of JSIS (1990)</u> Article 18 - Extension

If he/she does not undertake any kind of gainful professional activity, the beneficiary may remain covered by the present system during a period of maximum twelve months starting from:

- The day on which he/she loses the status of dependent child or of a similarly dependent person
- On the date on which he/she loses the right to an orphan's pension.

GIP (extract from the text of the GIP of 2007) Chapter 2, point 7

7. THE PERIOD OF EXTENSION OF COVERAGE OF DEPENDENT CHILDREN OR SIMILARLY DEPENDENT PERSONS

ARTICLE 18 (see above)


7.1 If, during the extension provided for in Article 18 of the joint rules, the beneficiary enters gainful employment within the meaning of Article 2 of the joint rules, cover under the JSIS will be suspended. If this gainful employment ceases, cover will be provided again until the end of the initial 12-month period.

If a national security scheme imposes a probation period during which the payment of contributions does not entitle the contributor to any corresponding reimbursement of expenses, the JSIS will continue to cover the beneficiary during this period, until the end of the 12-month extension.

Members who wish to extend their cover must apply in writing to their Settlements Office. An extension cannot be granted automatically, even where a tax reduction is granted.

→ 5.2 SURVIVOR'S PENSION



Following the article on survivor's pensions in the 'Did you know' section of our June 2024 newsletter, we received several requests for clarification.

The article stated: 'If a retired civil servant has had several spouses, after having divorced and not remarried, the pension will be divided according to the years married to each spouse.

In response to these requests, we will therefore discuss the various conditions to be met for the sharing of the survivor's pension between several spouses.

Article 27 of Annex VIII of the Staff Regulations, which requires former spouses not to remarry and receive maintenance from the deceased, should be amended to add two conditions.

There are, therefore, three criteria for sharing the survivor's pension:

- 1. not to have remarried
- 2. she is receiving maintenance payments
- **3.** she must have been married to the deceased.

For the purposes of sharing the survivor's pension, the share allocated cannot exceed the

maintenance allowance, which itself cannot exceed the survivor's pension.

The assumption in 'What did you know' only considered the case where the deceased had not remarried.

However, this article also provides for 'the coexistence of several spouses entitled to a survivor's pension and one spouse entitled to a survivor's pension,' **and one surviving spouse entitled to a survivor's pension**, this pension shall be divided in proportion to the respective duration of the marriages (...)'. The same conditions of non-remarriage of the ex-spouse and alimony apply.

The award of a survivor's pension by a divorced woman who has not remarried and is receiving maintenance is not automatic. The person concerned must apply to the PMO and prove that she was receiving alimony before the death of her ex-spouse. As the retirement pension is still paid three months after the death into the deceased's account, the PMO will have time to check whether the maintenance resulted from a court decision or an agreement between the former spouses, officially registered [with a notary] and paid

monthly. If there are several ex-spouses, the PMO will divide the maintenance according to the marriage's length and the maintenance payment amount.

For example:

- X was married to Mrs Z for 24 years. With his first wife (A), he was also married for 24 years and gave her maintenance of €5,000 per month.
- With his second wife (B), he was married for 10 years with a maintenance allowance of €6,000 per month.

The total duration of the marriages is 58 years and the total survivor's pension is 60% of $\in 8,000$ (pension) = $\in 4,800$.

Of this €4,800, Mrs Z will get ²⁴/_{58ths}, i.e.
 €1986, A will also get €1986 and B will get ¹⁰/_{58ths} or €827.

The total may not exceed the survivor's pension amount.

It should be noted that the requirements of 1 year of marriage in active service or five years as a pensioner do not apply to divorced spouses receiving alimony to claim their share of the survivor's pension.

To find out more, you can ask the secretariat for the text I have written on this subject: 'Survivor's pension for the surviving spouse and divorced ex-spouse of a deceased civil servant.'

Ensure that your bank account details are up to date before November 2024

Due to upcoming changes of the accounting system, updating your bank account details will be difficult between 1 November 2024 and 1 February 2025.

While bank account changes can typically be scheduled in advance, we understand that unforeseen circumstances may require urgent updates, Should such a situation arise, please notify us via the FILIP application, and we will do our best to make the necessary changes. However, please be aware that due to the above-mentioned technical constraints, processing times for these requests may be extended during this period.

Reimbursement of medical expenses: Possibility to update incomplete requests

With the latest updates to MyPMO and JSIS online, the PMO made managing your requests easier than ever. There is no need to submit a new request if there were mistakes in your reimbursement claims.

Instead of having your requests rejected, you will now be prompted to **provide missing information or documents directly in the original request**. If the PMO notices missing details, you will receive a notification on MyPMO and JSIS online, as well as an email inviting you to log in and make the necessary updates. Once you've added the required information or documents, simply save and resubmit your request.

This new feature will be available for both medical **expense reimbursements** and **prior authorisation** requests.

You can choose to use either MyPMO or JSIS online at any time, all your records will be accessible on both platforms.

What's new in the MyPMO App

With the latest updates, <u>MyPMO</u> now offers almost all of the JSIS online features:

- Consult the complete list of reimbursable medications.
- Get assistance from the JSIS teams by easily sending a question, just like on JSIS online;
- Create and review a request for the recognition of a serious illness;
- If you reside in the Netherlands, you can create or review an affiliation request based on the agreement between PMO and the local insurer CZ.

By the end of the year, **screening** requests (the only missing feature) will be added to MyPMO, making MyPMO and JSIS online fully interchangeable for all your health insurance-related actions.

Beyond health insurance

- A new "My Rights" section marks the beginning of the SYSPER integration into MyPMO. You can now easily view your pension statements on MyPMO.
- You may also access your certificates and other documents on MyPMO (tax certificates, private address attestations, family composition certificates, as well as documents related to allowances and other benefits you are entitled to).
